# What is the FDDC?

- State Developmental Disability Councils
   Authorized by the Developmental Disabilities Assistance and Bill of Rights Act of 1970, AKA DD Act
- The Florida Developmental Disabilities Council, Inc. Established in 1971
- Purpose of Act

  People with intellectual and developmental disabilities (INDs and DDs) and their families have the community services, individualized supports and other assistance they need that promote self-determination, independence, productivity, and integration and inclusion in all facets of community life

# CTE Initiatives Supporting Comprehensive Postsecondary Programs for Students with INDs and DDs

- FDDC has funded two projects in Florida's dual CTE system that transition secondary students to postsecondary education
- The first project was at Florida State College at Jacksonville, a state college
  - Project Achieve/Vertical has completed its fifth and final year of FDDC funding
- The second project is a **school district** initiative at Robert Morgan Education Center and Technical College
  - Project TOPS has been funded by FDDC for a second year



# Why Did the Council Fund CTE Programs?

- Students enrolled in postsecondary adult vocational programs (PSAV) programs can earn meaningful credentials that lead to employment:
  - Reach occupational completion points (OCPs)
  - Earn certificates for completion of an entire CTE program
  - Earn industry certification
  - With additional support, students with INDs and DDs master the same competencies as other students
  - Earn a Workforce Certificate in Career Education that teaches job skills and soft skills that lead to getting and keeping a job (Project Achieve/Vertical)
- For the years 2011-16, students enrolled in Project Achieve/Vertical CTE Programs other than Career Education for Students with Disabilities completed at a 72% rate (49 of 68 students)



#### Transition Services Delivery Models

- The Workforce Innovation and Opportunity Act (WIOA) mandates certain pre-employment services for students that can be funded through Vocational Rehabilitation:
  - Job exploration counseling
  - Work-based learning experiences
  - Counseling on postsecondary opportunities
  - Workplace readiness training
     Instruction in self-advocacy
- This Florida State College at Jacksonville project funds urban and rural models for the delivery of these services
- Intent is to develop models that lead to employment of students with INDs and DDs at wages at or above minimum wage

**Employment First Act requires certain state agencies and** organizations to develop an interagency cooperative agreement to ensure a long-term commitment to improving employment outcomes for individuals who have a disability-413.80, Florida Statutes

- The Employment First Initiative Interagency Cooperative Agreement signed in May 2014 represented unprecedented interagency collaboration among nine state agencies and organizations including the FDDC
- The Florida Grassroots Group is composed of self-advocates and local stakeholders representing a cross section of persons with various disabilities
  The Grassroots Group is facilitated through an FDDC contract with the Institute for Community Inclusion (ICI) which hosts quarterly employment-related topical webinars

#### **FDDC Employment Projects**

- Employment Options Informed Choice Training: The purpose is to develop and implement a training package that will provide persons with INDs and DDs the information and experiences needed to make an informed choice regarding accepting subminimum wage employment versus competitive employment at or above minimum wage
- Employment First Collaborative Training: The purpose is to provide collaborative training, technical assistance, and resources for agency and organization staff engaged in securing and supporting employment for all individuals with disabilities, including persons with INDs and DDs, so that they will realize and sustain quality integrated competitive employment at or above minimum wage

- Elementary to Postsecondary Transition Goal, Goal 3
  - By the end of the five-year state plan, the Council will have contributed to the implementation of at least four new improvements to transition services and two or more policies or practices that assist students with INDs and DDs from elementary through post-school transition into meaningful post-school outcomes with adequate services and supports.



# Transition Goal Objective 1

 Throughout the five-year State Plan, collaborate with agencies, school districts, and programs to create or expand two or more practices designed to improve transition outcomes for students with INDs and DDs from elementary through postsecondary education/training.



# Objective 1, Key Activity 1

- Develop a system to provide transition services to students with INDs and DDs, with an emphasis on students with the most significant disabilities, including youth previously thought unemployable.
- In year 1, use a framework of Florida and national best practices to develop a strategic plan and summary report that prioritizes strategies and practices for each age range (elementary through postsecondary education)
